Pricing: On site, all fees paid are CASH ONLY, no checks will be accepted. **Pie Feast is limited, so pre-registration is highly recommended.** Pre-registrations will be accepted through May 6, 2017. Registrations will not be processed without payment and requested registration information (this document). All required information must be supplied for every registration. All waivers and release forms (see below) not received/signed will be requested/returned. Proof of membership will be requested at troll. If you cannot provide proof of membership, non-member fees apply. Per Kingdom law, no family shall pay more than 3 adult prices, as long as they are all members. Family is defined as custodial adults plus legal dependents. Proof of immediate family relations and age may be required. Transfers of registration are allowed. Transfer requests will be accepted up to the day of the event, as long as received in writing and includes the same information in your request as you included on your pre-registration form.

Note: There is a bounced check fee of \$30 as allowed by Georgia law.

Note: Proof of membership is defined as a membership card, mailing label from a Society publication showing membership # and expiration date, payment acknowledgement from Society registry, or statement showing check payment of charge to Society registry.

Minor Age Children: Children 17 and under attending without their Parent/s or court-appointed legal guardian must have all three Society waivers. The waivers must be completed offsite and in accordance with the laws of your Kingdom and your state of residence. Contact your local or kingdom seneschal for the required paperwork.

Refunds: The registrationcrat must RECEIVE requests for refunds in writing postmarked or emailed no later than 05/01/17 and should include the same information in your request as you included in your registration form. Requests should be sent to Lady Celeste Des Fleurs at the above listed contact information. After 05/01/17, all refund requests are processed at the discretion of the registrationcrat and autocrat, and only for serious situations that would result in someone not attending LMOM.
